Community Health Centers Essential Points of Care for Low-Income Women Serving 1 in 5 low-income women of childbearing age, CHCs enhance access and reduce disparities

WASHINGTON and NEW YORK – A new report titled, “Role of Community Health Centers in Providing Services to Low-income Women,” released today by the Geiger Gibson /RCHN Community Health Foundation Research Collaborative in the Department of Health Policy at the George Washington University School of Public Health and Health Services examines the significant role community health centers (CHCs) play in providing services to low-income women of childbearing age (defined as age 15-44). The authors found that nationally, community health centers provide a medical home for approximately 5.4 million women of childbearing age, or more than one in five low-income women annually. The report also addresses the role of CHCs in mitigating health disparities and identifies the challenges that they will need to overcome to expand capacity and serve a greater number of high-risk, low-income women.

“Community health centers demonstrated success bodes well for further mitigating disparities and generating cost savings as they expand their capacity to serve more low-income women. However, they will have to manage ongoing funding gaps and lack of a trained health care workforce to meet the increasing demand for care,” said Peter Shin, Ph.D., M.P.H. Associate Professor and Director of the Geiger Gibson Program in Community Health Policy, and lead author of this study.

Nationally, the number of women who sought health care at community health centers has increased by 94% over the past decade. The Affordable Care Act (ACA) contains several provisions, including \$11 billion in health center funding, Medicaid expansions, and the establishment of health insurance Exchanges, that could significantly aid health centers in further expanding capacity and ensuring favorable health care outcomes. However, community health centers face a number of obstacles related to provider shortages, reductions in federal base funding and threats to key provisions under the ACA. These challenges could undermine community health center expansion and in so doing, disproportionately weaken the health care infrastructure for low-income women, and threaten the potential for improved access and outcomes.

“Community health centers have a long and successful track record of providing high quality, cost effective care to women in low-income communities.” said Julio Bellber, president and CEO of the RCHN Community Health Foundation. “Every effort should be made to sustain and support health centers so that they can continue to address disparities and help improve care outcomes.”
